## CMSP END OF CERTIFICATION INFORMATION NOTICE

There are two purposes for this letter. The first purpose is to inform counties that on July 27, 2006 the CMSP Governing Board approved the recommendation of the CMSP Eligibility Committee that the 10% increase in CMSP eligibility administration funding for FY 2006-07 be allocated across the board to all counties. To assist counties with budget planning, the attached spreadsheet presents the approved CMSP eligibility administration allocations to counties for FY 2006-07.

In addition, the purpose of this letter is to transmit the CMSP "End of Certification Informing Notice" that has been approved for use by counties as an optional form. Counties that implement a process to notify CMSP members about the approaching end of their CMSP certification period may utilize this form to notify CMSP members. Counties are instructed to use the county's standard letterhead when utilizing this Informing Notice.
