Description of Eligible Person	Medically indigent adult who meets all CMSP eligibility criteria and is not otherwise eligible for Medi-Cal or other publicly funded health coverage.																								
Age Limits	21 through 64 years of age.																								
Residence and Citizenship	California residence. Residence in a CMSP county. Full Benefits: A citizen of the United States or an alien who is: lawfully admitted for permanent residence; permanently residing in the United States under color of law. Emergency Services Only: Person whose immigration status has not been determined.

Relative Responsibility	Spouse for spouse. Parent for ineligible child living in parent's home.

Share-of-Cost (SOC)	(Net nonexempt income) minus (Need Standard) times (.25) equals share-of-cost. Share-of-cost must be paid or obligated before certification for program benefits. SOC is waived for applicants with incomes up to 138% FPL.																								
Certification Period Limits	6 months*—Emergency Services Only coverage Up to 6 months*—No share-of-cost and share-of-cost Full Scope coverage * An additional one month of retroactive eligibility is also allowed. All clients wishing to continue their eligibility beyond the certification period may reapply.																								
Provider Network	All approved Advanced Medical Management and MedImpact providers.
