

**Allied Healthcare Loan Repayment Program (AHLRP) for the
County Medical Services Program (CMSP)**

This program is funded by the County Medical Services Program (CMSP). Eligible applicants may receive loan repayments of up to \$16,000 in exchange for a one-year service obligation practicing direct patient care at one of the CMSP contracted facilities or clinics in any of the 35 CMSP designated counties.*

The application cycle will be open August 1, 2019 – October 8, 2019. To apply, visit <https://eapp.oshpd.ca.gov/funding/>.

***CMSP Designated Counties**

The 35 CMSP participating counties include: Alpine, Amador, Butte, Calaveras, Colusa, Del Norte, El Dorado, Glenn, Humboldt, Imperial, Inyo, Kings, Lake, Lassen, Madera, Marin, Mariposa, Mendocino, Modoc, Mono, Napa, Nevada, Plumas, San Benito, Shasta, Sierra, Siskiyou, Solano, Sonoma, Sutter, Tehama, Trinity, Tuolumne, Yolo, and Yuba.

Who may apply?

Health Professions Education Foundation is only awarding Allied Healthcare Professionals in CMSP designated counties, facilities, and professions. To be eligible for the Allied Healthcare Loan Repayment Program, the applicant must be currently licensed and practicing one of the following Allied Healthcare professions:

In addition, applicants must:

- Be providing direct patient care 32 hours or more per week
- Be in good standing with respective licensure, board of certification
- Have outstanding educational debt from a commercial or U.S. governmental lending institution
- Be free from any other service obligation, including other Health Professions Education Foundation programs
- Be willing to continue working in a medically underserved area for twelve (12) months
